2. **Acknowledge and hereby accept my role and responsibilities on behalf of my team, viz –**
  - 2.1 I am the official contact between the Organising Body and the Team
  - 2.2 I am responsible for presenting all necessary paperwork at scrutineering
  - 2.3 It is my responsibility to ensure my team members abide by the rules of the competition and act within the spirit of the event and I understand that the event organisers have the right to disqualify/penalise any team/team member not acting safely or not complying with the rules.
  - 2.4 I, or my declared proxy, must be present in the Team's pit area throughout the event and have the nominated contact mobile phone with me, turned on and not diverted or switched to message bank
  - 2.5 I must be present at the Team Managers' meeting of the event (this applies to Team Managers and/or their nominated proxies for the event)
  - 2.6 I will not be a riding member of the team, unless permission is obtained from the Organising Body at least one week prior to the event
  - 2.7 I will ensure all members (and/or their legal Guardian where required) have read and understood all relevant Rules, Guidelines, Safety Procedures and Specifications issued for each event and are aware of the consequences of any infringement.
  - 2.8 It is my responsibility to ensure each rider has all necessary adjustments in their vehicle made before they enter the track, especially seat belts. This should primarily be achieved through establishing the Team's practised protocols.
  - 2.9 I have a responsibility and duty of care to the riders of the vehicle to, at all times, monitor that the rider protection structures are adequately strong enough to meet their purpose and that all other aspects of the vehicle do not compromise rider safety at any time.
  - 2.10 I am responsible for the conduct of those in or associated with the team.
  - 2.11 I am responsible for ensuring that all areas used by the team, its support staff and visitors during the event are kept tidy and are left tidy after the event.
  - 2.12 I will brief all team members on their obligations and on suitable behaviour.
  - 2.13 I am satisfied that all participants in my team have sufficient experience and competence to participate safely in the event;
  - 2.14 I will ensure that the team's HPV named above meets to the best of my ability, all the criteria listed in the Scrutineering Checklist before the vehicle is presented for scrutineering
  - 2.15 Form all team members understand that the organisers take no responsibility for loss or damage to property or for personal injury and have understood the "Release and Indemnity Clauses" detailed in Form 3.
  - 2.16 Have fulfilled my obligations, in particular, as outlined in Clause 4 of Form 3.
